## West Boylston Municipal Lighting Plant 2010 Residential Energy Star Appliance Rebate Incentive

West Boylston Municipal Lighting Plant is pleased to offer rebates to customers purchasing selected energy efficient ENERGY STAR refrigerators, clothes washing machines, dishwashers or unit air conditioners. ENERGY STAR appliances have been defined by the Department of Energy (DOE) as being significantly more energy efficient than the average comparable model. Advantages of purchasing ENERGY STAR appliances are:

Potential savings in energy costs of between 15 and 50%.  
Reduction of global energy consumption and need for additional generation  
Decrease in pollution from fossil fuels used to generate electricity

### **REBATE ELIGIBILITY REQUIREMENTS**

- Customers must reside at the address for which they have an active residential account with WBMLP
- Rebate will be applied as CREDIT to electric account, and will appear on customer ELECTRIC BILL.
- Only selected ENERGY STAR refrigerators, clothes washing machines, dishwashers, or unit air conditioners are eligible for rebates. Appliances that may qualify will have the ENERGY STAR logo on the yellow EnergyGuide label attached to the appliance (see illustration below).
- Proof of purchase in the form of the sales receipt dated between January 1, 2010 and December 31, 2010, a copy of the EnergyGuide label from the appliance purchased, and a completed West Boylston Municipal ENERGY STAR Appliance Rebate Incentive Application are required in order to be eligible for a rebate. *(Note: The last day for submittal of 2010 completed paperwork will be April 15, 2011)*
- Rebate amounts: Refrigerators \$50., Clothes Washers \$50., Dishwashers \$25., Unit Air Conditioners \$25.,
- Offer limited to \$150. per household, per calendar year
- Appliance must be installed at the account location.
- West Boylston Municipal Lighting Plant reserves the right to inspect the installation on premises.
